UN Women's Sixth Safe Cities and Safe Public Spaces Global Leaders' Forum will be held in Quito, Ecuador from November 28th to 30th 2023 on the theme "Strategic Foresight and Issues on the Horizon". It will include leaders/experts from more than 20 countries, including those participating in comprehensive human rights and evidence-based programmes in the Safe Cities and Safe Public Spaces Global Flagship Initiative. This includes grassroots women and girls/women's rights and other community organizations, national and local governments, research institutes, representatives from the private sector and other partners from global women's safety networks. The Global Forum forms part of UN Women's commitment under the Action Coalition on Gender Based Violence that aims to share and discuss results, keys lessons learned, and support new partnerships to advance the international knowledge base and programme action on ending sexual harassment and creating safe cities and public spaces for women and girls.

Objectives:

- Support a cross-regional face to face learning platform for gender equality, women's empowerment and ending violence against women and girls in agreed upon thematic areas. Forum exchanges will continue to inform the Online Knowledge and Exchange Platform: Global Safe Cities and Safe Public Spaces Community of Practice focused on the prevention and response to sexual harassment and other forms of sexual violence against women and girls in public spaces, in line with the UN reform.
- Discuss safe city free of violence against women and girls' policy and programme action that can be further built to scale within and across cities and countries, as part of the localization of the Beijing Platform for Action, the New urban agenda and the Sustainable development Goals (SDGs). UN Women's Flagship continues to focus on implementing strategic women's rights approaches with a focus on leave no one behind (LNOB), shared accountability, and evaluability for impact.
- Strategize how the global movement on women's safety in cities, rural spaces, and other settings (online, conflict, etc.) can maximize its policy and advocacy impact, including through UN Women's generation equality campaign.

Three key takeaways from the Global Forum include:

Heightened engagement among multi sectoral stakeholders to implement safe and sustainable cities with women and girls' policy and programme action.

Tools and applied lessons learned to further strengthen comprehensive multi-sectoral evidence, and human rights-based approaches to prevent and respond to sexual harassment and other forms of sexual violence against women and girls in public spaces.

Good practices in the implementation of safe city and safe public spaces programming, which contributes to SDGs: 4,5,11, and 16.

Snapshot for 2023 Safe Cities and Safe Public Spaces Global Leaders' Forum

Through interdisciplinary expert-led discussion and debate with over 200 safe city stakeholders committed to transformational change in lives of women and girls in cities worldwide, this 2023 Forum will include:

- A country-hosted meeting on the first day of the Forum which provides participants with a deep understanding of the national and local trends and developments related to sexual harassment and other forms of violence against women and girls, and within the continuum of violence. This will include:
 - Plenary/moderated panel sessions on National Trends and Developments in Ecuador on Ending Violence against Women and Girls in public and private spaces and in multiple settings.
 - Concurrent sessions/workshops on addressing violence against women and girls in the country, highlighting practical interventions that form part of a comprehensive evidence based multi-sectoral approach.
- Fourth Global Meeting of Mayors for Gender Equality and Women's Empowerment: A Commitment to Accelerate Action: Focused on city leader commitments to further implement multiple SDGs, the New Urban Agenda, and the Beijing Platform for Action (approaching 30 years since adoption) through integrated policy and programme action. The meeting is convened by UN Women with the city of Quito-as a founding safe city programme in the country (with 10+ years implementation).
- International Days of the Forum focused on addressing contemporary challenges and partnership solution including:
 - Plenary/moderated armchair dialogue sessions on 1) Trends and Developments to localize the Sustainable Development Goals, including through the SC/SPS Global Flagship Initiative and 2) Innovation and multi-sectoral partnerships to address complex challenges in safe public space initiatives
 - An information and exchange roundtable led by partners in the women's safety movement to improve the knowledge and skills of multiple partners working to prevent and respond to sexual violence, and further build on the momentum created by #MeToo and other movements.
 - Dedicated spaces for exchanges and quick chats to learn about new developments and good practices in safe city and safe public spaces with women and girls' initiatives.
